# **Lottery Vending Machines Help Clubhouse**

"The Kansas Lottery is excited to join the majority of other states offering the convenience of selling lottery products through self-service vending machines," said Stephen Durrell, the lottery's acting executive director.

The Kansas Lottery has recently rolled out the first of 272 vending machines it plans to put in stores with high-volume sales and lots of foot traffic. The bill authorizing the vending machines provides that up to \$8 million of the profits will go toward mental health services starting in fiscal year 2020, which begins July 1. It's been estimated that the machines could increase sales by up to \$100 million.

The lottery is placing vending machines at four locations in Topeka, and plans to install the others at select locations across the state next month. The state has about 1,700 lottery retailers.

The first pilot program locations are at the Topeka businesses listed below, with more expected across the state:

Gage Center Bowl, 4200 SW Huntoon Street, Topeka: John's Food Center, 5812 SW Topeka Blvd, Topeka; Kansas Lottery Headquarters, 128 N. Kansas Ave, Topeka; West Ridge Lanes, 1935 SW Westport Drive, Topeka.

The lottery also is working on plans to take ticket sales online, but that will need to be approved by the Legislature.
